CONDITIONS OF SALE
PLEASE READ CAREFULLY

1. Consignment blanks must be accompanied by a **copy of horse's registration papers** and the **Catalog Fee**.
2. All horses will be screened. Must be gentle, and will sell with that guarantee.
3. Special Horse Sale and its associates act as agent only on all sales and are not responsible for buyer seller error or misunderstanding.
4. **ALL HORSES MUST BE SOUND WITH NO BAD HABITS. NO EXCEPTIONS.**
5. The commission will be eight percent (8%) of the selling price. The consignor will have the privilege to no sale (Pass Out) his horse. If the horse is passed out, there is no pass out fee.
6. Three-generation pedigrees will be printed in the catalog on all horses consigned. Complete sire and dam notes based on the current statistics of the American Quarter Horse Association, American Paint Horse Association and Appaloosa Horse Club will be furnished on all horses. Any other association must be furnished by consignor.
7. **Only horses consigned to the sale will be allowed on the sale grounds.** All horses sold before, during and after the sale will be subject to the 8% sales commission in addition to the catalog fee. **All consignments must go through the sale ring.**
8. Transfer fees for Quarter Horses will be deducted from the seller.
9. Individual **NEGATIVE COGGINS TEST** current within 6 months and a **HEALTH SHEET** is required for each horse.
10. **The catalog fee is nonrefundable.** Consignor agrees to not withdraw entry except for **serious injury or sickness**, and will furnish Special Horse Sale with a notarized veterinary statement prior to the sale.
11. Upon execution of this contract, **Consignor agrees not to dispose of the horse by private sale.** Any horse withdrawn from the sale, for any reason other than infirmity will be assessed a **\$200 penalty in addition to the \$75 catalog fee or 8% of the selling price, whichever is greater.**
12. Consignors will be paid in 5 banking days after sale day.
